Building Permit Application Fee Refund where plan checking has not commenced.

There will be no refund of any portion of the application fee once the plan checking has been started.

For single- and two-family dwellings, including renovations, additions and accessory buildings	70% of application fee subject to a minimum non-refundable amount of \$189.50
For all other applications	70% of application fee subject to a minimum non-refundable amount of \$189.50
Building Permit Fee Refund where construction has not commenced, no inspection has been made and a permit has not been extended or expired	Refund equals 90% of the difference between the Building Permit Fee and the Building Permit Application Fee subject to a minimum non- refundable amount of \$380.50
For any permit or special inspection where no Application Fee is charged. Refunds will be made only where work has not commenced, no inspection has been made and a permit has not been extended.	70% of the Permit Fee subject to a minimum nonrefundable amount of \$380.50
