Electrical Installation for New One- and Two-Family Dwellings

Electrical system for a dwelling including service connection and Temporary Current Permit	18% of building permit fee
Security system, data, cable, TV, vacuum, intercom, sound system, and telephone	Fees shall be charged under Electrical Installations Other than New One- and Two-Family detached dwellings (Minimum \$274.50 job value)

Where it has been determined by the Electrical inspector that due to non-compliance with the provisions of the Bylaw or incomplete work, re-inspection is required.

Special Inspections

Special Inspection Fees subject to all applicable taxes and must be approved by the Chief Building Inspector

For an inspection outside the hours during which the offices of the City are normally open	\$647.50 plus \$165.50/hour or part thereof after the first four hours (travel time include)
For a voluntary inspection (<i>including Provisional Occupancy</i>) requested by the owner, occupant, or contractor during City normal business hours to establish the condition of a building or structure	\$115.50/ hour or part thereof (\$115.50 minimum)
For an inspection that requires special arrangements because of length of time, frequency of inspection visits, location outside the City limits, construction techniques or otherwise	\$115.50/ hour or part thereof (\$115.50 minimum)
Strata title subdivision application inspections	\$255.50
Permit Fee Refund	90% of the fee paid subject to a minimum nonrefundable amount of \$189.50
