For installation of appliances: For complete appliance and installations with fixtures	\$67.00 for the first appliance and \$37.00 for each additional appliance	
Residential vent installation only - no appliance installed:		
For vent installation only	\$67.00 for the first vent and \$37.00 for each additional vent	
Residential piping only – no appliance installed:		
For the first 30m of piping or less	\$64.00	
For each additional 30m of piping or portion thereof	\$36.00	
Gas Installation in Commercial, Industrial, Institutional or Multi-family		
For each appliance with an input of:		
30 kW (102,000 BTU/Hr) or less	\$66.00 for the first appliance and \$54.50 for each additional appliance	
31 kW to 120 kW (103,000 to 409,000 BTU/Hr)	\$112.00	
Piping only – no appliance installed:		
For the first 30m of piping or less	\$66.00	
For each additional 30m of piping or portion thereof	\$46.00	
Vent installation only – no appliance installed:		
For each vent installation only	\$65.00	
Laboratory equipment:		
For each 200,000 BTU's or part thereof in a room	\$93.00

For the transfer or assignment of a gas permit and to record a change of contractor for a project	\$140.00

Re-inspection Fee

Where it has been determined by the gas inspector that due to non-compliance with the provisions of the Bylaw or incomplete work, re-inspection is required.

Special Inspections

Special inspection fees subject to all applicable taxes and must be approved by the Chief Building Inspector

For an inspection outside the hours during which the offices of the City are normally open	\$647.50 plus \$165.50/hour or part thereof after the first four hours (travel time include)
For a voluntary inspection (including Provisional Occupancy) requested by the owner, occupant, or contractor during City normal business hours to establish the condition of a building or structure	\$115.50/ hour or part thereof (\$115.50 minimum)
For an inspection that requires special arrangements because of length of time, frequency of inspection visits, location outside the City limits, construction techniques or otherwise	\$115.50/ hour or part thereof (\$115.50 minimum)
Strata title subdivision application inspections	\$255.50
Permit Fee Refund	90% of the fee paid subject to a minimum nonrefundable amount of \$189.50
