Plumbing Fixtures

(Fixtures shall include but not be limited to the following: roof drain, floor drain, dishwasher, clothes washer, water heater, water meter or backflow protection device under 4 inches in size with test ports)

For new single- and two-family dwellings	,

Re-inspection Fee

Where it has been determined by the Plumbing inspector that due to non-compliance with the provisions of the Bylaw or incomplete work, re-inspection is required.

For a voluntary inspection (including Provisional Occupancy) requested by the owner, occupant, or contractor during City normal business hours to establish the condition of a building or structure	\$115.50/ hour or part thereof (\$115.50 minimum)
For an inspection that requires special arrangements because of length of time, frequency of inspection visits, location outside the City limits, construction techniques or otherwise	\$115.50/ hour or part thereof (\$115.50 minimum)
