Children with life-threatening allergies requiring emergency medication, an Auto-injector (EpiPen), may be able to participate in the City of Burnaby’s arts and recreation programs where the Parent/Guardian is prepared to accept the risks inherent in the Child participating in the program with staff trained only in First-Aid treatment.

Upon registering for a program, the Parent/Guardian is responsible for contacting the program supervisor **at least 2 weeks in advance** of the program start date to discuss their Child’s life-threatening allergy(s), the program details (the “Program”), and the emergency plan. This form must be completed, signed and returned to the program supervisor, before the start of the program. The Parent/Guardian or designate must remain on site with the Child’s Auto-injector (EpiPen) during the program.

PARENT AUTHORIZATION, ASSUMPTION OF RISK AND RELEASE OF LIABILITY – to be reviewed, initialed and signed by Parent/Guardian

I have reviewed this document with the program supervisor/designate of the program I have chosen for my Child.

I agree that I, or my designate, will remain on-site for each program session and will have a valid single-dose, single-use Auto-injector available.

I understand if I fail to remain, my Child will be withdrawn from the program ***and I will need to arrange for them to be picked up immediately.***

I agree I am responsible for providing City staff updated information prior to current or future registration should changes occur regarding my Child's life threatening allergies.

By signing this form I confirm the information provided is accurate and I or my designate are responsible for assisting my Child by administering their single-dose, single-use Auto-injector and obtaining medical assistance in the event of a suspected anaphylactic reaction.

I am aware of the risks inherent with my Child suffering an anaphylactic reaction while participating in the Program and I assume the risks.

On behalf of my Child, I HEREBY RELEASE AND HOLD HARMLESS the City of Burnaby together with its designated agents and staff (the "Released Parties") from any and all claims suffered or incurred or brought against the Released Parties that my Child or myself may have, in law or in equity, by reason of administering, or failure to administer the Emergency Plan to my Child while attending the Program, notwithstanding that the same may be contributed to or occasioned by the negligence of the Released Parties.
