- Opportunity Assessments: Up to 100% funding (to \$5,000) for high-level evaluations to identify retrofit opportunities
- Feasibility Studies: Up to 100% coverage of study costs (to \$30,000) for an in-depth analysis of a specific retrofit project.
- **Rebates:** Up to 50% of incremental project costs (to \$500,000) in rebates for space heating including heat pumps, domestic hot water, ventilation, controls, electrical capacity upgrades, windows, and lighting upgrades

Additional Incentive Programs for MURBs

Register for the RARA Program at landlordbc.ca/rara to receive retrofit planning support and assistance to potentially access the following incentives:

- <u>Clean Technology (CT) Investment Tax Credit (ITC):</u> A refundable federal tax credit of up to 30% for new clean technology investments.
- BC Hydro Solar and Battery Storage Rebate Program: Incentives for installing solar panels (up to \$10,000) and battery storage systems (up to \$10,000) for MURBs, helping reduce electricity costs and increase energy independence.
- Clean Buildings Tax Credit: A 5% refundable income tax credit for qualifying retrofits that improve energy efficiency. Eligible retrofits include heat pumps, lighting, fans, envelope upgrades, and more.
- Canada Housing and Mortgage Corporation CMHC MLI Select Program: An innovative multi-unit mortgage loan insurance product focused on affordability, accessibility, and climate compatibility.
