

Public Notice is hereby given in accordance to Section 227 of the *Community Charter* that the City of Burnaby intends to provide exemptions from property taxation for lands and improvements of the properties listed below by adopting "Taxation Exemption Bylaw 2023, Amendment Bylaw No. 1, 2025", Bylaw No. 14767. The Burnaby Taxation Exemption Bylaw 2023, Bylaw No. 14609 valid from January 1, 2024 to December 31, 2026, will be amended to reflect the removal, changes or additions of organizations in the bylaw. The 2027 and 2028 figures are illustrative only and are not included in the Burnaby Taxation Exemption Bylaw 2023. Actual values may vary upon receipt of the assessment roll for each year. The proposed Bylaw will be presented for Final Adoption at the City Council Meeting on October 28, 2025 at Burnaby City Hall Council Chambers, 4949 Canada Way, Burnaby BC V5G 1M2.
