Notice is hereby given that pursuant to s. 464(1)(a), 465 and 466 of the *Local Government Act* and s. 94 of the *Community Charter*, Burnaby City Council will hold a Public Hearing to receive representations in connection with the proposed “Burnaby 2025 Official Community Plan Bylaw” (OCP) on October 6, 2025 at 5 pm in the Council Chamber, 4949 Canada Way, Burnaby BC V5G 1M2.

### 1) Burnaby 2025 Official Community Plan Bylaw, Bylaw No. 14762

**Purpose:** to replace Burnaby’s Official Community Plan Bylaw 1998 with an updated Burnaby 2025 Official Community Plan (OCP). The Burnaby 2025 OCP establishes a new community vision, supported by land use and policy frameworks that guide growth in Burnaby for the next 25 years.

**Applicant:** City of Burnaby
